



REQUIREMENTS FOR REQUESTING PERMANENT RADIATION BY SUACE

- I. ECONOMIC SOLVENCY:** *For foreign investors who apply for permanent residence through the S.U.A.C.E. Present the following documents:*

CONSTANCE signed by the Vice Minister of Industry and Commerce.

(1 Original and 2 authenticated copies.)

- II. IDENTITY DOCUMENT: Identification Card or RG or Passport or ID**

If the document is not in Spanish, you must submit the Translation edited by a Public Translator registered by the Supreme Court of Justice.

(1 Original and 2 authenticated copies.)

OBS: Present visa and visa verification for countries that require it.

- III. CERTIFICATE OF BIRTH**

Apostilled in country of origin or Visa by the Paraguayan Consulate in the country of origin and Legalized by the Ministry of Foreign Affairs in Asunción, located in Alberdi and Eduardo Víctor Haedo. If the document is not in Spanish, you must submit the Translation Edited by a Public Translator registered by the Supreme Court of Justice of Paraguay.

(1 Original and 2 authenticated copies.)

- IV. CERTIFICATE OF MARRIAGE OR DIVORCE SENTENCE: (*)**

Apostilled in country of origin or Visa by the Paraguayan Consulate in the country of origin and Legalized by the Ministry of Foreign Affairs in Asunción, located in Alberdi and Eduardo Víctor Haedo. If the document is not in Spanish, you must present the translation edited by a Public Translator registered by the Supreme Court of Justice of Paraguay.

(1 Original and 2 authenticated copies.)

- V. CERTIFICATE OF PENAL BACKGROUND OF THE COUNTRY OF ORIGIN: (*)**

Apostille in country of origin or Visa by the Paraguayan Consulate in the country of origin and Legalized by the Ministry of Foreign Affairs in Asunción, located in Alberdi e / Eduardo Víctor Haedo. If the document is not in Spanish, you must submit the translation edited by a Public Translator registered by the Supreme Court of Justice of Paraguay.

(1 Original and 2 authenticated copies.)

- VI. MIGRATORY COUNTRY ENTRY CARD OR SEAL IN PASSPORT:
(2 authenticated copies.)**

- VII. HEALTH CERTIFICATE**

The certificate must mention that the applicant has good physical and mental health and does not suffer from infectious diseases and be legalized by the Ministry of Public Health and Social Welfare, located on the streets of Brazil and Manuel Domínguez.

(1 Original and 2 cups authenticated.)

- VIII. INTERPOL CERTIFICATE:** Issued by the Interpol Department of the National Police.

X. CERTIFICATE OF COMPUTERS OR OF ANTECEDENT FOR THE FOREIGN:

Issued by the Information Department of the National Police with a seat in the Identification Department, located at Av. Boggiani and RI 2 Ytororó.

- For BRAZILERS: You can present one of the two Certificates mentioned in Item 4. For all other nationalities you must present both Certificates
- Documents in Portuguese language of Brazil do not need translation.
- The documents of the country of origin requested as a requirement by law, authorizing the issuance of the same in the embassies and consulates with representation in the Republic of Paraguay, will be admitted after legalization of the same in the Ministry of Foreign Affairs. In case the documents of the country of origin are apostilled, they do not need legalization of Foreign Affairs. Authenticated copies must be made in the Paraguayan office. In the Affidavit should mention the number of signature certification sheet.
